## CANCELLATION POLICY AGREEMENT

### **\*How do I cancel my Athletic Club Membership?**

You can cancel your membership in writing by filling out a Membership Update form to the front desk at the Athletic Club prior to the 15<sup>th</sup> of the month. For example, if you cancel on January 14<sup>th</sup>, you will not be charged for February. If you cancel on February 3<sup>rd</sup>, then you will be charged for February but not March. **Each time you rejoin the Athletic Club there is a processing fee of \$39.00.**

### **\*How do I cancel the tennis or croquet portion of my membership?**

You must do so by the 25<sup>th</sup> of the month prior to cancellation. Tennis or croquet memberships can only be purchased in full month increments. For example, from the 1<sup>st</sup> to the 31<sup>st</sup> each month, no prorated monthly memberships.
