Tennis only memberships do not include use of the gym, pool area, or fitness classes. Please ask for a tennis-only specific membership at the club desk.

STUDENT MEMBERSHIP: \$55 per person month. Open to full-time High School /College Student. Copy of Student ID and parent/guardian contact information and signature on Membership application is required.

CORPORATE MEMBERSHIP: \$75 per person, monthly. Corporate Membership is offered to a business for a minimum of 4 adults. The business is charged each monthly for all members on their Corporate Membership with one credit card. CIVIC MEMBERSHIP: \$75 per person, monthly. The civic membership is offered for Windsor County Supervisory Union and Town of Woodstock employees. An ID or pay stub is required for validation at time of signing and each year.

CANCELLATION POLICY AGREEMENT

***How do I cancel my Athletic Club Membership?**

You can cancel your membership in writing by filling out a Membership Update form to the front desk at the Athletic Club prior to the 15th of the month. For example, if you cancel on January 14th, you will not be charged for February. If you cancel on February 3rd, then you will be charged for February but not March. **Each time you rejoin the Athletic Club there is a processing fee of \$39.00.**

***How do I cancel the Unlimited Court, Add-On portion of my membership?**

You must do so by the 25th of the month prior to cancellation. Tennis or croquet memberships can only be purchased in full month increments. For example, from the 1st to the 31st each month, no prorated monthly memberships.
